

1. Trade Fair: **KRAKIDENT® International Dental Trade Fair in Krakow.**

3. Trade Fair Commencement Date: **11.04.2024, from 10:00 a.m.**
4. Trade Fair Closing Date: **13.04.2024, to 5:00 p.m.**
5. Deadline for Confirmation of Participation: **7 days.**
6. Deadline for refusal of Confirmation of notification: **7 days.**
7. Assembly day: **8-9.04.2024 (from 8:00 a.m. to 8:00 p.m. – non built-up space) and 10.04.2024 (from 8:00 a.m. to 8:00 p.m. – exhibition space + stand construction and standard stands).**
8. Disassembly day: **13.04.2024, from 5:00 p.m. to 12:00 midnight, 14.04.2024 (from 8.00 a.m. to 6 p.m.).**
9. Due date for payment of fees in accordance with clause 3.3:
  - **registration fee: within 3 days of confirmation of the application,**
  - **in case of using of the discount\*, the total gross payment for the ordered space must be made by 12.01.2024.**
- \*DISCOUNT – Companies participating in KRAKIDENT® for:
  - the 30<sup>th</sup> time – 20% discount of the price of space ordered
  - the 20<sup>th</sup>-29<sup>th</sup> time – 15% discount of the price of space ordered
  - the 19<sup>th</sup>-10<sup>th</sup> time – 10% discount of the price of space ordered
  - the 9<sup>th</sup>-1<sup>st</sup> time – 5% discount of the price of space ordered
10. The due date for the payment of fees under clause 3.4:
  - a. instalment 1 in the amount of **45%** of the gross payment resulting from the order in the Exhibitor Panel, paid as an advance **until 12.01.2024;**
  - b. instalment 2 the remaining part of the total gross payment resulting from the order in the Exhibitor Panel to be paid by **2.04.2024.**
11. Deadline for cancellation of participation in the Fair as referred to in clause 4.1 and 4.2 of the Regulations: **to 31.01.2024.**

13. Deadline for reporting changes in equipment and media: **to 11.03.2024.**

15. List of regulations applicable to Co-exhibitors: **Fire Safety Instructions, Technical, anty-fire and BHP regulations, Using EXPO Krakow object regulation, Using charged parking spots regulations.**
16. The deadline for notification of the need for the use of cranes, hoists, etc. resulting from clause 8.4: **to 1.03.2024.**
17. Deadline for submitting a online catalogue entry in the Exhibitor Panel: **to 1.03.2024.**
18. Deadline for registration of guests and speakers as per clause 9.13: **to 11.03.2024.**
19. The amount of the fee for the first and second commenced man-hour of extension of the assembly day: **NET 750 PLN + VAT** at the applicable rate. Fee for the third and each subsequent commenced hour: **1000 PLN + Vat tax.**
20. The amount of the fee for the first and second commenced working hour of extension of the disassembly day: **NET 750 PLN + VAT** at the applicable rate. Fee for the third and each subsequent commenced hour: **1000 PLN + Vat tax.**
21. Official freight forwarder of the Trade Fair: **TRANSMEBLE INTERNATIONAL Ltd.**
22. In the event that as a result of the current pandemic situation a ban on the organization of exhibition events is introduced, paid advance payments will be returned **within 30 days of the cancellation of the Fairs or credited towards the next edition**, if such is the decision of the Exhibitor. **The registration fee is not refundable however the Exhibitor who transfers the advance payment to the next edition of the Fairs will be exempt from it.** Points 14.4 and 14.5 of the Regulations do not apply.
